
STEP 1








STEP 3





You can create your campaign anytime from 27 August onwards. Your campaign must end by **26/09/22(2359)**.


-Campaign URL



Frequently Asked Questions

Do I need to pay to create my virtual can?

No, creating a virtual can is free!

Do I need to create an account on Giving.sg before donating?

Yes, all donors need to create an account on Giving.sg before they are able to donate.

When do I start my campaign?
You can start it anytime from 27/08/22! The campaign must end by 26/09/22,
(2359). (refer to Step 6).

What do I do after my campaign has been approved?

Share the link with your family and friends. Encourage them to donate and adopt a virtual can.

Can I edit my campaign after it has been approved?

Yes, you can edit your campaign story,
fundraising goal and media gallery.

Which donations are eligible to receive a tax-deductible receipt?

Donations of SGD10 and above are eligible for 250% tax-deductible benefits.

Where will the funds raised go?

All funds raised will support CCSS programmes and services. Your efforts will equip our beneficiaries with skills and resources to be self-sustainable and lead empowered lives.

Is my donation refundable?

All donations made are non-refundable. As a non-profit organisation, CCSS relies largely on donations for our programmes and services that serve over 1,000 beneficiaries.

CCSS is unable to make refunds because the donation may have already been used to meet the needs of our beneficiaries.
